Rate to be offered to Senior Citizens would be 0.50% additional on all Term Deposit Schemes for 1 year to less than 5 years.

For 5 years and above — A special "SGB Senior Citizen Care Scheme" introduced for senior citizen in the Term Deposit (TD) segment wherein an additional premium of 30 bps, over & above the existing 50 bps as detailed above will be paid to Senior Citizens on their retail TD for "5 Years and above" tenor only and same benefit is also available to ex-staff members who fall under senior citizen category. • For Staff Members:
